Loudon County

This application must be signed under oath in the presence of a notary public and submitted to the County Clerk prior to the meeting of the county commission at which it is to be considered. Once elected, you must then be commissioned by the Governor. If elected, you will be required to post a bond in the amount of Ten Thousand Dollars (\$ 10,000). If you move your residence or your physical place of business out of this county, you are required by law to notify the County Clerk of the change and be charged a fee of Seven Dollars (\$ 7.00)

- Applicant must be a United States citizen or a legal permanent resident. (TCA 8-16-101)
- All notaries must be 18 years of age or older.

A notary is elected to a four year term by the county legislative body in the county where he/she resides or has principal place of business. Your application and fee must be received in our office by the 20th of each month prior to the next County Court meeting in
- 1st time applicant: \$33.90 (includes notary stamp) Renewal: \$14.00. A \$10,000.00 bond for the term of office is required. (Do not get your bond before your commission is issued. Our office will contact you with your commission date.)
